Mayor's Report

Mayor Cummings spoke of the village sign at the west edge of town. He said the state will not allow business advertisements but will allow information of events the village and/or the schools have scheduled. MABA no longer wants anything to do with the sign. The village can take control of the sign but would have to pay for the replacement of the technical parts. Martin Sign has quoted the estimate of \$13,600.00 to do this. He said no decision is needed at this time, but asked the Board to consider what they prefer to do. More discussion on this would be forthcoming.

He gave a short update on the solar farm saying the work on the access road will be starting shortly. The work on the farm should start in the fall and hopefully be completed in 2025.

A resident had sent a letter asking for permission to have a community garage sale on Lloyd Lane in Sept. or October. She wanted to know if they could block the street with barricades for this sale. The board had no major objections to this.

Next, the mayor said Big Papa Jake's had reached out to him wanting permission to bring his food truck to the square on Wednesday nights during September and possibly October. The board saw no problem with this.
