# MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES FOR THE VILLAGE OF METAMORA, IL., HELD SEPTEMBER 5, 2023

The regular meeting of the Board of Trustees for the Village of Metamora was called to order at 7:00PM.

Village Clerk, Bylle Long, called the roll call.

Minutes of the regular meeting held August 5, 2023, were reviewed. Trustee Alig made a motion for approval with Trustee Nauman seconding. With a vote of 5 yeas, 1 abstain (Bowers) and 0 nays, the motion passed.

The Warrant List was reviewed. Trustee Weyeneth made a motion for approval with Trustee Bowers seconding. With a vote of 6 yeas and 0 nays, the motion passed.

## **Public Works Dept.**

After discussion at the committee meeting, Trustee Nauman made a motion to approve Stephens 3D to do alley work in the amount NTE \$30,000.00 Trustee Weyeneth seconded the motion and with a vote of 6 yeas and 0 nays, the motion passed.

Also discussed at committee meeting was the need to purchase a new F250 truck when it could be found. Trustee Nauman made a motion to approve giving authority to Jason Jones to purchase such a truck, when he could find one, in the amount NTE \$65,000.00. Trustee Weyeneth seconded and with a vote of 6 yeas and 0 nays, the motion passed.

Trustee Nauman set a tentative date for the next committee meeting for September 26, 2023 starting at 5PM.

#### Police/Fire/ESD

Trustee Schierer made a motion to upgrade the lights on Rescue 203 in the amount of \$9961.00 from Pulse Services. Trustee Glueck seconded and with a vote of 6 yeas and 0 nays, the motion passed.

Trustee Schierer made a motion to purchase connector elbows from MES Fire in the amount of \$1800.00. Trustee Glueck seconded and with a vote of 6 yeas and 0 nays, the motion passed.

Trustee Schierer made a motion to approve the purchase of a water thief part for the fire dept. from MES Fire in the amount of \$2367.00. Trustee Glueck seconded the motion and with a vote of 6 yeas and 0 nays, the motion passed.

All three of these purchases were discussed at the previous committee meeting with Fire Chief McCullough.

Mayor Cummings reported that our grant had been sent back to us from Rep. LaHood's office with suggestions to add more support letters, the difficulties we will have in getting more EMT's with the facility we now have, sending pictures showing our facility now and explaining the need for improvements. They would like a timeline of construction and a general statistical breakdown. These suggestions will be to our benefit for approval of a grant and we will have to re-submit the application in the spring.
