1.Digital Copy Billboard – Lease has been approved for property at corner of Rt 89 &116 for the installation of a digital billboard. Public hearing on zoning changes set for Jan. 29th and will be presented to Village Board for approval at Feb. 6th meeting.

2. Metamora Park District – Both Village Board & Park District have approved the development of an Intergovernmental Agreement for Village takeover of the Park District operations while retaining the Park District for taxing authority and overall planning. A draft of the proposed Agreement will begin.

3. Renewal of farm lease / 2024 crop season – Lease agreement being prepared for discussion with Village Board.

- 1. Unexpected funds from Build Illinois Bond Fund to DCEO as a grant for infrastructure improvements in amount of \$50,000.00. Decision for which project to direct this grant will be needed.

- 3. Streetscape Planning committee. Concept handout and discussions for envisioning possibilities for sidewalk reconstruction around square are needed.
